**AGREEMENT
BETWEEN
CAPITAL AREA FINANCE AUTHORITY
AND
LINCOLN PARISH**

This agreement (the "**Agreement**") is entered into by and between the Capital Area Finance Authority (the "**Authority**"), herein represented by Mark Drennen, its President and CEO, duly authorized, and Lincoln Parish, herein represented by its Police Jury President, who, in order to serve the public for purposed herein, stated, declared.

WHEREAS, the Authority is a public trust established for public purposed for the benefit of East Baton Rouge Parish, State of Louisiana (the "**Beneficiary**"), created pursuant to the provisions of the Louisiana Public Trust Act, Chapter 2-A of Title 9 of the Louisiana Revised Statutes of 1950, as amended La. R.S. 9:2341-247, inclusive (the "**Act**"), and other constitutional and statutory authority supplemental thereto and by that certain Trust Indenture dated August 14, 1974 and all amendments thereto (the "**Indenture**"); and

WHEREAS, the Indenture empowers the Authority to promote, encourage and further the accomplishment of all activities which are or may have a public purpose, including, but not limited to, the development of safe, sanitary single family housing for the low and moderate income families of the Beneficiary, for projects authorized under the Act and the Indenture which shall be deemed an authorized public function under the provisions of the Act and;

WHEREAS, Article VII, Section 14 (C) of the Louisiana Constitution of 1974 and Sections 9020 through 9037, inclusive, of Title 33 of the Louisiana Revised Statutes of 1950, as amended, authorizes the parties to enter into this Agreement for the purpose of engaging in or encouraging economic development; and

WHEREAS, the Authority and Lincoln Parish desire to enter into this Agreement for the benefit of the citizens of Lincoln Parish and the Beneficiary, for the purposes of allowing low to moderate income borrowers of Lincoln Parish to participate in the Authority's program of financing homeownership for low and moderate-income families (the "**Programs**") and for the Authority to earn administrative fee in accordance with the terms of this Agreement; and

WHEREAS, the Program will be administered by the Authority on behalf of Lincoln Parish in accordance with the terms of this Agreement.

IT IS AGREED, by and between the Capital Area Finance Authority and Lincoln Parish, that the following Agreement be adopted and the same is hereby entered:

1. TERM: The term of this Agreement shall commence on the first date below written and shall continue in effect until terminated by either party

by providing thirty (30) days written notice to the other party of its desire to terminate.

2. PROGRAM TERMS: The Program shall be administered by the Authority on behalf of the Parish pursuant to the terms and conditions of certain mortgage origination agreement ("**MOAs**") by and between the Authority and various lending insitutions ("**Lenders**") in connection with the Authority's Program.
3. PROGRAMS: The Authority presently has three mortgage loan programs which are detailed on Exhibit A and additional mortgage loan programs are expected to be developed. The Authority will share 50% of the net fee with the Parish.
4. ADVERTISING AND MARKETING: In connection with its administration of the Program, the Authority shall actively market the Program in coordination with representatives of the Parish. The Authority shall be responsible for and pay directly any and all costs associated with the advertising and/or marketing of the Program.
5. MUTUAL AND RECIPROCAL BENEFIT: The Authority and the Parish acknowledge and agree that the obligations and agreements of each are in consideration of the obligations and agreements of each other and are of mutual value.
6. ASSIGMENT: Neither the Authority nor the Parish shall assign any interest in this Agreement and shall not transfer any interest in same (whether by assignment or novation), without prior written consent of the party.
7. AMENDMENT IN WRITING: Any alteration, variation, modification or waiver of provision of this Agreement shall be valid only when it has been reduced to writing and executed by all parties.
8. AUDIT CLAUSE: It is hereby agreed that the Legislative auditor of the State of Louisiana, and/or the Office of the Governor, Division of Administration auditors shall have the option of inspecting and auditing all data records and accounts of the Authority which relate to this Agreement, upon request.
9. NOTICE: All notices and other communications pertaining to this Agreement shall be in writing and shall be transmitted either by personal hand-delivery (and receipt for) or deposited in the United States mail, as certified mail, return receipt requested and postage prepaid, to the other party, addressed as follows:

WHEREAS, the Code of Federal Regulations as enacted by the United States Congress mandates that all structures defined as bridges located on all public roads shall be inspected, rated for safe load capacity and posted in accordance with the National Bridge Inspection Standards and that an inventory of these bridges be maintained by each State; and

WHEREAS, the responsibility to inspect, rate and load post those bridges under the authority of Lincoln Parish in accordance with those Standards is delegated by the Louisiana Department of Transportation and Development to Lincoln Parish.

THEREFORE, BE IT RESOLVED by the governing authority of Lincoln Parish (herein referred to as the Parish) that the Parish in regular meeting assembled does hereby certify to the Louisiana Department of Transportation and Development (herein referred to the DOTD) that for the period 1 October, 2019 through 30 September, 2020:

1. The Parish has performed all interim inspections on Parish owned or maintained bridges in accordance with the National Bridge Inspection Standards.
2. Bridges owned or maintained by the Parish have been structurally analyzed and rated as to the safe load capacity in accordance with AASHTO Manual for Maintenance Inspection of Bridges. The load information that has been determined by the LA DOTD for all bridges where the maximum legal load under Louisiana State law exceeds the load permitted under the operating rating as determined above has been critically reviewed by the Parish. Load posting information has been updated by the Parish to reflect all structural changes, any obsolete structural ratings or any missing structural ratings.
3. Parish owned or maintained bridges which require load posting or closing are load posted or closed in accordance with the table in the DOTD Engineering Directives and Standards Manual Directive No. 1.1.1.8 All DOTD supplied load posting information concerning a bridge has been critically reviewed by the Parish Engineer prior to load posting.

- 4. Bridges owned or maintained by the Parish are shown on the attached list in the format specified by the DOTD. Corrections to data supplied to the Parish by the La. DOTD are noted. These stipulations are prerequisites to participation by the Parish in the Off-System Bridge Replacement Program.

VIOLENCE AGAINST WOMEN ACT (VAWA)

We also work with our local DART program. If a participant is facing termination because of domestic violence, dating violence, or stalking the participant must provide a signed statement to verify the act(s) of violence which will result in the participant being eligible for relocation. We will bypass standard procedures for the relocation and safety of the participant and the family.
