WHEREAS, under LSA-R.S. 42:141(C), a vacancy exists in the position of Police Juror, District 3, Lincoln Parish, Louisiana; and,

**WHEREAS**, under the provisions of LSA-R.S. 18:602 (E), the Lincoln Parish Police Jury has the obligation to call an election to select a successor.

**NOW, THEREFORE, BE IT RESOLVED** by the Lincoln Parish Police Jury in legal and special session acting as the governing authority of the Parish of Lincoln, State of Louisiana that:

1. Under the authority conferred by LSA-R.S. 18:602(E), a special election is hereby called and ordered to be held in Lincoln Parish on November 3, 2020, between the hours of 6:00 am and 8:00 pm for the purpose of electing a Police Juror from District 3, Parish of Lincoln, said post being declared vacant. The General Election date, if required, will be December 5, 2020. The qualifying period for this election shall be July 15, 16, and 17, 2020. This Resolution and Notice of Election shall be published in The Ruston Daily Leader, a daily newspaper of general circulation within the parish published in Ruston, Louisiana, being the official journal of the governing authority for the Parish of Lincoln, on February 26 and March 4 and 11, 2020. A copy of this Resolution ordering and calling the special election for the position of Police Juror, District 3, Parish of Lincoln, shall be furnished to the Clerk of Court and Registrar of Voters, Parish of Lincoln, and to the Secretary of State of the State of Louisiana.
